NOTE: SAFER Adoption Policy No cats/kittens can be adopted without an application. If you fail to complete the entire application it will slow down the adoption process. We want to ensure our kitties are going to responsible pet owners! Approval depends on how long it takes to verify your information. The process usually takes 3-7 days, provided all information is accurate. The adoption fee is \$100 for one kitten up to 16 weeks of age or \$175 for two kittens, and \$75 per cat or \$125 for two cats. The adoption fee for cats over five years of age \$25. The adoption fee covers testing for feline aids, feline leukemia, spaying/neutering and initial vaccines.
